- b. the Company's website in Bahasa Indonesia and English

The Shareholders of the Company that entitled to attend or to be represented at the Meeting are the Shareholders whose names are registered in the Company's Shareholders Register on 28 April 2016 at 16.00 Western Indonesia Time.

Shareholders who own 1/20 (one-twentieth) or more of the issued capital of the Company can make proposals on matters to be included in the agenda of the Meeting if such proposals are submitted in writing to the Board of Directors at the latest 7 days before the Notice, that is 22 April 2016, and also comply with the requirements stipulated in Article 12 paragraph 3 and 4 of the POJK and Article 10 paragraph 2 of the Company's Articles of Associations.
